# e. (iii) EG SW Regional Com Rep read by Margaret Allen

- a. Meeting at Woodhall Spa concluded the voting on the constitution of the board
- **b.** Numbers of golf club members have decreased but the downturn has slowed. EG are looking to increase affiliation fees in 2019 and this will be on the agenda for the April meeting
- **c.** On 27.2.18, a meeting has been arranged to discuss the implications of a merger with SGU with Rod Finlay, an EG representative
- **d.** Flyers for all SW events are now available. SW Foursomes event is being held at Weston super Mare GC on 4.10.18 and is being arranged by CP

## (iv) Handicap Advisor

- **a**. Two handicap meetings have been held and were attended by 43 people covering 20 clubs along with representatives from the County, SW and EG. Discussions concerned the upcoming Annual Review with new changes effective form 1.1.18. If clubs haven't yet carried out their Annual Review, it can delayed until the end of February so that increases in handicap up into the new Category 6 can be included.
- **b**. Category 6, with handicaps up to 54, was discussed at length and the implications for including ladies in Cup, Trophy and Open competitions
- **c**. Nine hole competitions are now available as medals and a nine hole stableford can be run alongside monthly medals. Clubs cannot restrict who can play in 9 hole competitions
- **d**. Competition Standard Scratch Adjustment is not mandatory: there are possibly some software issues with this
- **e**. A combined set for minutes for the two handicap meetings were sent out to Handicap Secretaries and are available on the website
- **f**. There is a Handicap meeting to be held in February where details are to be given for changes in 2019 and this will be attended by JF and MA. Meetings will be run to advise Handicap Secretaries of the implications for 2019
