Minutes of the Somerset County Senior Ladies Golf Association Annual General Meeting

Held at the Stockwood Vale Golf Club on Monday 18th October 2021 at 3pm

Yvette Gregg (President) opened the meeting by welcoming everyone to Stockwood Vale Golf Club before introducing the Lady Captain, Julie Poole, who also welcomed Members to the club, apologising that the weather did not behave, but hoping ladies had enjoyed playing the course enough to come back to play the full 18 holes! Yvette thanked Sarah, Martin Edenborough (Club Manager), Lee Jennings for all his work with the cards, setting up the putting competition and sorting out the results, Catering and Bar Staff & Pro Shop and also the volunteers from the club who helped the morning run as smoothly as possible.

1. **Minutes of the Annual General Meeting 2020** Yvette reminded the meeting that, as stated on the agenda, last year members received a set of reports which took the place of the normal AGM, which could not take place due to Covid restrictions. Therefore, as there were no objections to the reports Yvette then signed a copy of the reports to be filed with the minutes. There were no matters arising from these reports
2. **Captain's Report** Note this includes a report from South-West Veteran Ladies Golf Association (SW Vets). In the absence of Jill Paul, Marilyn Kirby read the following report:

After a difficult 2020, 2021 brought a sense of relief and optimism. However, everything was not back to normal. Meetings, apart from one Officers' Meeting, have been via Zoom. We have been on a steep learning curve to work with this medium, but I think, on the whole, it has been good. It has been such a treat to be able to hold Inter-County Matches. Although fewer ladies signed up to play there was still a good number of Clubs represented and a range of Handicaps.

Cornwall and Devon decided not to play so the SW Vets Shield was not played for. Hopefully, it will be back next year. We have had Friendly matches against Gloucestershire at Gloucester GC, Wiltshire at Long Sutton GC. Hampshire at Royal Winchester GC and Dorset at Ashley Wood GC. A good variety of Courses and weather greeted us. The team sheets had to be changed on a number of occasions for various reasons, but we had 14 ladies for each match. We beat Gloucestershire and lost to Wiltshire and Hampshire (although many were very close matches). We halved with Dorset. Some teams had more Division 1 ladies than us, but this won't be able to happen in the Shield Matches next year. Somerset ladies always looked smart and there was a great sense of camaraderie. I felt very proud.

The 5th match was one that I decided to hold to make up for not playing against Cornwall and Devon. It was held at Taunton and Pickeridge. There were 28 ladies and I mixed up Clubs and Handicaps to make a Captain's and Vice-Captain's teams. The matches were close: each team won three and halved one, so a glorious Draw! This was a fun day and maybe a fixture to be repeated?

Thanks to Vice-Captain Chris for putting my Reports and photos on the website. I do hope you look at it from time to time as Chris has done a great job in making it more user-friendly.

SW Vets Report. (Cornwall, Devon, Dorset, Somerset). Unfortunately, both SW Vets Field Days were cancelled this year as last, and also the Shield matches. The new ways of working, because of Covid have actually helped the SW Vets become a more coherent group because Zoom meetings have been held every 3 months. The AGM is on 25 October on Zoom and the updated Constitution will be ratified. Dorset have run the Vets well this year; they continue next year and then Somerset takes over.

Remember that as a Somerset Senior you are automatically a member of SW Vets so look at the website later in the year for information on the Spring and Autumn Field Days in 2022.

I would like to thank all the ladies who have played in Matches this year. At the start of the season, I wondered whether any would happen, so it was a real joy for me to organize a nearly normal year. It would not have happened without the Delegates (I have discovered what an important job they do), and a supportive, friendly and efficient Committee. Special thanks go to Chris, my Vice-Captain (she must have wondered if she would ever take over!) and President Yvette (a superb chair which stems from lots of work behind the scenes). It has been such an honour to serve as your Captain for 2 years; 2 years I will remember for all sorts of reasons! Finally, I would like to wish Chris and Carole a happy and successful year as Captain and President. Somerset Seniors will be in good hands.

3. **Vice-Captain's Report** Christine Harris gave the following report:

I have enjoyed my two years as Vice Captain although there have not been many matches to go to. I have really enjoyed working with Jill, her upbeat way of looking at things, her attention to detail and her efficiency have I fear, left me a very hard act to follow.

I would like to congratulate Jill on the success of this year's matches. It has been particularly hard this year because of not being allowed to travel until May, with cancelled and re-arranged matches and the inevitable self-distancing. However, Jill worked her magic and managed to get teams together.

Uniform sales have been good with white fleeces proving very popular, so much so that we are going to have to restock over the winter. Unfortunately, it has been decided that as Balmoral have ceased production of the green sleeveless sweater and we are unable to source a supply of

a similar colour, this item of stock will be discontinued. We will keep to white sleeve sleeveless sweaters for the future.

Matches for 2022 have been arranged, although we still await a date for the away Shield match against Dorset and a list of dates should have been included in paperwork given to you on arrival. I do have some additional copies if required. We can only hope that all Shield matches will be played next year, dates are already in place, but we will have to wait and see whether Devon and Cornwall feel the time is right to resume County matches.

An annual plea no doubt, but when you sign up to be considered for a match, please check the dates carefully. If you are nominated as a reserve, I would be grateful if you keep that date free because you may be needed, and sometimes at quite short notice. We do try to be as fair as possible and give everyone a game or be on the reserve list at least once. The matches are excellent value for money (£20 for a match followed by a meal).

I look forward to meeting many of you at next year's competitions and matches, but be warned, although I may well recognise your face, it is more than likely that I will have forgotten your name. Don't be afraid to come and say 'Hello, I am Candy from Cannington'. I can assure you I will be delighted and certainly not offended.

4. **President's Report** Yvette Gregg gave the following report:

I have been honoured to be your Somerset Senior Ladies President for the last 16 months. The task is not yet complete, but much work has been done to make certain that this year's prizes are in place and more progress will be made next year. So, in your absence many thanks Linda and we wish you well in the future and will no doubt meet up in Opens and matches etc. (Note Yvette will give Linda a plant as a token of appreciation at a later date)

Caroline Lumley-Frank kindly accepted the position as a co-opted member of the Committee. Her vast knowledge as a Past President and running the SW Vets has been invaluable to me.

Although Caroline is leaving the Committee, I know that she will always take an active interest in the Section. I think you have been a Senior from 2002 when you joined Long Sutton. In recognition of all that you have done Caroline, I am delighted present you with an Honorary Life membership, which has been fully endorsed by the Committee. Thankyou Caroline for all your help and friendship. (Yvette then presented Caroline with a plant as a token of appreciate)

Unfortunately, no one has come forward to take on the position of secretary for next year and Marilyn has very kindly volunteered to continue in her post **for 1 year only**. This would be the ideal opportunity for a member to come forward and shadow Marilyn and learn the ropes in preparation on becoming the secretary for the year 2022 onwards. Yes, it is daunting, but the committee is so friendly and supportive and the plus points of the camaraderie and the satisfaction of completing a worthwhile job is immense. So, please, spread the message amongst your Ladies.

My last mention is to Carole. I asked Carole if she would consider becoming my Vice President when I hurriedly had to take over as acting President. 6. **Competition Secretary's Report.** Janet Handley gave the following report:

7. **Treasurer's Report** (Note Copy of audited accounts filed with these minutes). Hilary Dennes gave the following report:

Copies of the Annual Accounts are available to examine. They showed an overall profit for the year of £124.16. After two very unusual years, the Association's finances are gradually getting back to normal. However, the accounts bear little resemblance to previous years', for the following reasons:

- Subscriptions this year amounted to only £95, reflecting the fact that existing members were not asked to pay this year, as the previous year's subscriptions had been largely unused. Only new members were asked for subscriptions.
- Travel costs have been minimal compared with 2019 and prior, as most meetings have been held by Zoom.
- Officers' honoraria were not paid this year, apart from one new eligible Officer, who had not received an honorarium the previous year.
- Match fees were all for Friendly matches, as Shield matches did not take place this year.
- No engraving costs were incurred during the year, since there had been no trophies presented which needed engraving.

In future, it is hoped that payments for entries to matches and competitions can largely be carried out using internet banking, since most members are now accustomed to internet banking, rather than using cheques.

In spite of my trepidation when I agreed to take on the role of Treasurer, I have very much enjoyed working with the SCSLGA Committee during my three years in the post. They are such a supportive, friendly group that I have always felt able to ask for advice if needed. I am sure the new incumbent will feel the same.

8. **Secretary's Report** Marilyn Kirby gave the following report:

It doesn't seem possible that it's three years since I was appointed Secretary. While there have been challenges, I have really enjoyed the role; especially working with such a great group of ladies. While the Covid Pandemic has presented the Committee with many problems during the past year, thanks to Zoom Meetings, we have actually met more frequently than in normal times, which in turn has meant we have really bonded together as a team.

As Yvette has just said I have agreed to stand for a further year as Secretary. However, this is definitely for **one year only** as I have several holidays, including to Australia, that have been postponed due to Covid travel restrictions and are now re-booked for late 2022 and later in 2023. Also, I strongly believe both the Secretary and the Treasurer posts should be for a maximum of 3 years. Any longer and it is likely to deter ladies offering to take these roles on. So, **please** think carefully about whether either **you** or a member in your club could take this on. If anyone here this afternoon feels this might be something they could do, then **please** talk to me at the end of the AGM and find out more about what's involved.

9. **Membership Secretary's Report** Fay Galley gave the following report:

We have currently 460 Seniors lady members in Somerset.

I would like to take this opportunity to thank the delegates for sending me their lists of members. At the same time, I need to remind you that I, and the Secretary need to know every time the Seniors Delegate changes in your club. The Delegate is the main point of contact for all of our officers. County Matches and the Competitions are more difficult to organise without this information. Please let both of us know as soon as a delegate changes.

I will also, when the information for 2022 is finalised, be distributing the leaflet with all the Seniors County information on, to the delegates. Thank you

10. **Proposal regarding Committee Membership** On behalf of the Committee Marilyn read the following proposal: "The President, having served her year, remains on the Committee as Past President for a further year to aid continuity and to support the incoming President". Marilyn then asked the meeting, by a show of hands, to approve this proposal; agreed unanimously.

11. **Ratification of Officers** Marilyn read the list of Officer appointments (see below) for the coming year and asked the meeting, by a show of hands, to approve the appointments en-bloc. The meeting approved these unanimously.
